- 9. Approval of Special Meeting Minutes for June 1, 2023 Meeting Corrections requested by Tomlinson. Motion to approve corrected minutes by Becker; seconded by Tomlinson. All in favor, 3; opposed 0. Motion carried.
- Rauls Rezone Discussion & Action Andrew Groves of Planning Commission recommended the board approve the rezone request to rezone 2.8 acres from A-1 Agriculture land to an existing RR-1 Rural Residence Lot. Motion to approve Rauls rezone by Schack; seconded by Becker. All in favor, 3; opposed 0. Motion carried.
- Discussion w/ Possible Action, Reduce Posted Speed on King Rd. (West of Hwy. 22) Todd Hultman presented board with a petition to reduce speed signed by 21 residents. Discussion held. Schack to discuss with Sheriff on possible signage. Motion by Becker to table reducing speed until next month by resolution. Schack seconded. Tomlinson yes. Motion carried.
- 12. Town Website Updates/Access Discussion & Action Darin Curtis (administrator) does not recommend non-IT user uploading. Tomlinson to contact WTA on legality of Curtis as poster. Curtis requested board pay yearly renewal fee directly.
- 13. Discussion on Potential Uses for ARPA Funds potential uses: maintenance for town hall improvements (i.e., expansion, records room, ADA accessible back door (steps).
- 14. Discussion on Potential Ordinances Right of way; Adult Entertainment (with Plan Commission); Wind (with Plan Commission).
- 15. Town Dump Maintenance Discussion & Action Cleaning up/removal of odds and ends; power washing grounds; building shelter for employee; swinging gate (need price); new signage for hours.
- 16. Town Hall Maintenance Discussion & Action Power washing building; bring furnace up; new add a/c; drive thru recycling (need to check on septic); new/larger bulletin board brought in for announcements.
- 17. ERN Replacement Signs Discussion w/ Possible Action Discussion of replaced signs and amount remaining in budget to replace some faded ones.
- 18. Roadwork Schack updated on the crack filing and seeding/bedding down by Five Star.
- 19. New Business approval of June 13, 2023 meeting minutes
- 20. Adjournment Motion by Becker; seconded by Tomlinson. Motion carried.
