Carrie Meyer, chief of Poynette-Dekorra EMS reported on 2017 EMS budget request. EMS staffing and method of payment was changed. Now paying \$2.00 per hour on call and \$20.00 per run for each of 3 staff on run. Historically, EMS staff were paid from a pot of money, New method increased budget need from \$56,000 to \$89,000. Caused a 8% to 9% increase in budget. Benefit of new plan is it increased coverage from 50% to 84%. They also changed the way they recruit new members. They are also a lot more active on social media and active in schools and in the community. A discussion followed. With levy limits Town has no way to increase its levy to absorb its share of Poynette-Dekorra Fire Dept. budget increase.
